Answers to Your Most Common Questions

1. What is 10-Year Group Term Life Insurance? How does it work?

To qualify, a terminally ill insured must provide the insurance company with proof of terminal illness and anticipated life expectancy (12 months or less), as well as any other necessary medical information requested. The request must be made at least 12 months prior to the insured person's scheduled coverage termination age.
